Next Chapter La Crosse 2020 Annual Report



From the Executive Director

Little did we know at the beginning of this year how unlikely a time this would be to begin this new venture amidst unprecedented uncertainties but the Lord has been more than faithful this first full year of Next Chapter La Crosse. This report is an opportunity for us to give a glimpse of the ways we have experienced His faithfulness in beginning our second chances stories here at Next Chapter La Crosse.

What we have set out to do is to provide a place where men who have been caught up in the cycle of incarceration and addiction can be built into men who are self-sufficient in the Lord Jesus Christ. We are convinced that what these men need is three-fold. First of all, we are seeking to provide the most obvious and straightforward need which is safe, secure and stable housing for these men. Secondly, in order for this housing to be effective we are seeking to build healthy a support network of positive relationships that will restore men to God, family and the community. And thirdly, by providing safe, secure and stable housing opportunity along with healthy community these men are to be able to maintain meaningful work.

The central activity of this year has been the establishment of our Discipleship Home. The opportunity to have a lease with Nehring Properties has afforded us the opportunity to get our program started this year. With the help of the skilled labor crew from Bethany Church and Nehring Properties willingness to let us do some significant renovations, we have been able to settle in to a house that is adequately suited for us to get started. It has also been a blessing that much of the furnishing, kitchen implements and technology have come to us through generous donations of individuals, churches and businesses. Since our opening July 1 we have had 5 residents, two of which are still in the house. I believe the Lord has allowed us to impact each one in their steps toward getting out of the cycle of incarceration and addiction.

We have also seen the Lord's hand in his provision for us financially. We have been fully funded for our first year. The Lord has sustained us even in this time of a pandemic through the giving of 56 individuals, 9 churches, a completely forgiven loan through the Payment Protection Program and our first major grant from the Robert & Eleanor Charitable Fund of La Crosse Community Foundation. I am also thankful for the year end provision that has put us in a good financial position that allows us to move ahead in 2021.

We have been blessed with significant media exposure that has given us broader community awareness. This has lead not only to donations but also inquires and referrals from agencies and community members who know men who might need what our program provides.

I want to thank all the board members, supporters and volunteers for all their work and encouragement in this first year of getting ourselves established.

- Established our location at 713 Ferry Street with a rental agreement with Nehring Properties
- Renovations to better serve our programing needs with volunteer skilled labor from Bethany Church
- Donations of furniture to kitchen implements from individuals, churches and businesses fill the house















...Where Men Become Residents

- 5 residents since our opening July 1
 - > 2 residents have been here from 3-6 months
 - > 1 resident returned home after 1 ½ months
 - > 2 residents were asked to leave
- Building a program routine
 - 2 meals and bible study for residents during the week
 - Saturday breakfast for a broader NCL covenant community
- Residents becoming students in partnership with WTC Project Proven
- Developing a Mentoring Program







The Lord's Financial Provision

- Fully Funded Our First Year (with a little extra)
 - 56 Individual Giving Units, 7 of them have been monthly
 - 9 Churches have given, 4 of them have been monthly
 - \$12,500 from the Payment Protection Program
- \$50,000 in year end giving to sustain us into the next year
 - Our first significant grant of \$25,200 from the La Crosse Community Foundation
 - \$25,000 received in the last 3 months of the year
